

Taschenspielertricks mit der EEG Umlage – AGORA fordert weitere EEG Subventionen..

Reduzierung der EEG-Umlage

In den letzten Tagen wurde in der Presse die Reduzierung der EEG-Umlage von 6,24 Cent je Kilowattstunde auf 6,17 Cent angekündigt. Dies ist nicht gerade viel, aber selbst diese winzige Senkung scheint einzig auf einem Buchungstrick zu beruhen. Der Bund der Steuerzahler meldet:

„Trügerischer EEG-Überschuss: Das EEG-Konto weist zum Ende August einen Überschuss von 1,5 Mrd. Euro aus. Der Überschuss ist jedoch hauptsächlich aufgrund einer Buchungsänderung entstanden. Die Zahlungen der sogenannten Marktprämie, dem zweithöchsten EEG-Ausgabeposten, werden künftig erst im Folgemonat

kontowirksam. Somit fielen im August einmalig Ausgaben von rund 700 Mio. Euro weg, die nun erst im September das Konto belasten werden. Aufgrund des Überschusses kann aber mit einer Reduzierung der EEG-Umlage zum Jahreswechsel gerechnet werden.“
